## URGENT FIELD SAFETY NOTICE

Concerned devices: Batec Handbikes of the MINI 2, SCRAMBLER 2, ELECTRIC 2 (which includes RAPID 2) and HIBRID 2 product lines.

This letter is to inform you of a voluntary field action being initiated by Batec Mobility. The affected handbikes are the MINI 2, SCRAMBLER 2, ELECTRIC 2 (which includes RAPID 2) and HIBRID 2 product lines. A full list of affected products is attached for your reference.

This field safety notice comprises important information that requires of your immediate action.

<b>SITUATION:</b>	Customers have reported noise and loss of some brake disc bolts. The possible cause of this loss of the screws is that they were not tightened properly.
<b>IMPACT:</b>	The loss of bolts in the brake disc leads to a loss of braking capacity.
<b>ACTION:</b>	<ol style="list-style-type: none"><li>1. Please inspect your inventory, locate any of the devices identified in the attached list of affected products with an affected SN and quarantine them immediately.</li><li>2. Distribute this notice to all your centres or customers to whom you have been able to supply concerned units, and to all relevant personnel of your company.</li><li>3. Distribute the enclosed end-user letter to all users to whom you have been able to supply concerned units.</li><li>4. Contact the Technical Assistance Service to repair the</li></ol>

	concerned units. 5. Complete the return slip (page 3) and send it to your national Batec Mobility distributor.
<b>SOLUTION:</b>	The official Technical Attention Services will carry out an inspection and repair of all the handbikes affected by this action.

This field action has been reported to the relevant competent authorities.

Please make sure this safety information is passed on to all those who need to be aware of it within your organization and maintain awareness on this notice and resulting action until the Field Safety Corrective Action is terminated to ensure effectiveness of the action.
