Subject : Combinations between Optimum and Optimum AC femoral stems size 0 and Titanium modular necks from Ceram Concept

Madam, Sir,

Reasons:

During preliminary tests to update Ceram Concept femoral stems endurance and performance characteristics following ISO 7206-4:2010, results revealed some combinations could not fulfill requirements of new standard version.

Combinations concerned are the following:

- Optimum size 0 (reference OPTI 0) femoral modular stem with titanium short or medium varus-valgus 15° neck (reference C0007 and C0008);

- Optimum AC size 0 (reference OPTIC 0) femoral modular stem with titanium short or medium varus-valgus 15° neck (reference C0007 and C0008).

Associated potential hazards:

In light of preliminary results, it is possible above combinations don't reach clinical performances (early break of the stem at distal part).

Ceram Concept wants to specify, since Optimum modular stem has been commercialized in April 2008 and Optimum AC in March 2009, none incident has been reported on these combinations. Potential hazard associated is low

Recommendations:

We recommend to surgeons who implanted one, or several, of these combinations to be vigilant during patient following visit in order to detect any eventual break beginning. We also recommend to surgeon not to implant one of these combinations anymore.
