1. Course objectives

General objective

The General objective of BTSF is to ensure a high level of consumer protection throughout the EU internal market and to increase levels of trade in safe food across the globe by the implementation of efficient, objective and adequate official controls. This objective is achieved by training the staff of the competent authorities, offering a better network and on-going dialogue with partners from both within, and outside, the European Union, thus contributing to a high level of expertise and competence.

Specific objectives

The specific objectives of the BTSF training activities on TRACES are to train staff involved in official control activities so as to keep them up-to-date with the use of the EU Trade Control and Expert System (TRACES).

Thereby, the programme will aim at ensuring a harmonised use of TRACES, taking into account the latest updates available. As TRACES is an IT tool in continuous development, the programme will also be flexible and able to adapt its contents to the new upcoming possibilities of the system.

Both the private and the public sector will benefit from a more harmonised use of TRACES and a deeper knowledge on the system by staff responsible for the official controls: better cooperation with customs, statistical data available, reduction of administrative work, faster clearance of the consignment at the border, etc.

2. Structure of sessions

The project is articulated in 5 courses for on the “Use of the EU TRAdE Control and Expert System (TRACES)”:

- Course 1. TRACES use at import of live animals and products of animal origin.
- Course 2. TRACES use at import of products of plant origin.
- Course 3. TRACES use at import of live plants.
- Course 4. TRACES use at import of organic products.
- Course 5. TRACES use in intra-EU trade of live animals and products of animal origin.

3. Selection criteria for participants

- Participant must:
1. Fulfil the eligibility criteria
 2. Meet the minimum requirements
 3. Be selected using the evaluation criteria

1. Eligibility criteria for Courses 1, 2, 3, 4 and 5

Participants who have previously completed the BTSF courses on **TRACES** should be assessed for their eligibility for this training based on the criteria below. Only **eligible participants** should be further assessed against the minimum requirements below.

Participants must meet the minimum requirements below to ensure they can follow and fully participate in this course. Participants who do not meet the minimum requirements should not be proposed for the training.

2. Minimum requirements for all Courses

Participant must:

- Relevancy to daily work: participants should have a technical background related to the area of training. It should be clear that the training activity will improve their daily work.
- Sufficient level of language and sound knowledge of computer: in order to ensure the transfer of knowledge and opportunities to exchange views, participants should master the language of the training session for which they applied
- Ability to share their experience: priority will be given to participants whose working position will allow sharing with colleagues the outputs of the training session.
- Dissemination of training material: commitment of the participants to disseminate the gathered information during the training session
- Be familiar with the principles of the organic farming scheme (for course 4).
- Courses 1 and 5 are designed for officers with an intermediate/advanced level on TRACES
- Courses 2, 3 and 4 are addressed to both TRACES users and participants without extensive experience in TRACES.

The evaluation criteria should be used as a tool to prioritise participation (higher score indicates higher priority), but there is no minimum score necessary.

Annex 1: Background and main topics covered in training

Background

The **TRAdE Control and Expert System (TRACES)** is the European Commissions' multilingual online management tool for all sanitary requirements on intra-EU trade and importation of animals, semen and embryo, food, feed and plants. Its main objective is **to digitise the entire certification process and linked procedures**, and is in line with the declaration of the Digital Agenda for Europe.

TRACES was launched in April 2004, and since then it has grown larger by diversifying both its activities and its target groups. After the initial certification modules for intra-EU trade and veterinary border control, many other modules have been introduced.

TRACES New Technology or TNT is new platform who bring those structural changes wished by users as well as an even more user-friendly interface. The certification in TNT module for organic production was launched on 4 April 2016 and it is already available for issuing COI, CHEDPP, PHYTO and FLEGT documents.

About 30.000 users all over the world are issuing more than 1.5 million certificates per year within TRACES. That is about 5.000 per day; half of them for the single market trade and the other half for imports into the EU and EU border control system.

In these conditions, being TRACES such a dynamic instrument where improvements and new tools are continuously added, specific training is necessary for guaranteeing a correct and updated use of the system, where users are aware of its possibilities and can benefit from all the available options.

Main topics covered in the training

- **Overview of TRACES:** General presentation on the system, its legal basis, functionalities and advantages.
- **TRACES Notifications:** Different notifications sent by the system, including the links to specific systems as RASFF and Europhyt.
- **TRACES Update:** Latest developments of the system and upcoming changes.
- **TRACES Re-enforced checks (Course 1):** Specific procedure based on article 24 to Directive 79/78/EEC, and how it's being applied in TRACES.
- **Animal Welfare (Course 5):** Animal welfare during transport, with particular emphasis on the preparation of the journey log and the infractions of Council Regulation (EC) 1/2005.
- **TRACES Trade (Course 5):** Particular cases of intra-EU trade, differentiating when the use of TRACES is compulsory or not.

Annex 2: Legislation and guidance

The EU is one of the most important players in the international trade in food and the biggest importer in the world. With regard to food safety, the EU has in place comprehensive legislation aimed at ensuring that all food for sale in the EU, produced in the EU or imported from other world regions is safe and complies with, or it is at least equivalent to, well defined standards.

Regulation 2017/625 (Official Control Regulation) require the Commission, in collaboration with the Member States, set up and manage a computerised information management system for official controls (IMSOC) for the integrated operation of the mechanisms and tools through which data, information and documents concerning official controls and other official activities are managed, handled, and automatically exchanged. The IMSOC integrate the existing Traces system.

COMMISSION IMPLEMENTING REGULATION (EU) 2019/1715 of 30 September 2019 laying down rules for the functioning of the information management system for official controls and its system components ('the IMSOC Regulation').

TRACES is the European Commission's online platform for sanitary and phytosanitary certification required for the importation of animals, animal products, food and feed of non-animal origin and plants into the European Union, and the intra-EU trade and EU exports of animals and certain animal products. Today, TRACES is an indispensable tool used in about 90 countries, from more than 55.000 users worldwide for the issuance of sanitary and phytosanitary certificates and official documents required for imports, exports and intra EU movements of live animals and goods.

The main objective of TRACES is to streamline the certification process and all linked entry procedures and to offer a fully digitised and paperless workflow.

It facilitates the exchange of data, information and documents between all involved trading parties and control authorities and therefore simplifies and speeds up the administrative procedures.

The possibility to trace back and forth all the movements of animals, animal products, food and feed of non-animal origin and plants contributes to the reduction of the impact of disease outbreaks and allows for a quick response to counter certain serious risks along the agri-food chain.

The TRACES platform enhances cooperation and coordination between the competent authorities of EU countries and non-EU countries, but also between the traders themselves and their competent authorities. When a decision is taken on a consignment, the involved parties are notified and have access to the relevant documents. TRACES allows for the quick detection of fake certificates and therefore contributes to the fight against food fraud and enhances cooperation and collaboration between authorities.

The integrated statistical tool allows the extraction of valuable data in relation to imports into the EU, exports from the EU and intra-Union trade.

Annex 4: Technical requirements

The VC sessions will be organised with the use of the Zoom web conferencing tool. The participants will take part in a short Zoom test training session the week before the actual session. The Zoom test training will help participants to become familiar with the Zoom platform. They will also receive some general information on the course and have the opportunity to ask questions.

The participants should have a computer with a working camera and audio system (speaker and microphone) as well as a good internet connection.

To avoid delays, the registered participants will be contacted for a technical test of their equipment a few days before the training sessions. This will allow participants to test their equipment and view the main features of the VC application platform. During this brief test, participants will have the chance to learn all the tools of the VC platform.

During this meeting, the Event Manager and Assistant Event Manager will also go through the main aspects of the agenda and different sessions that are foreseen. Additionally, in the morning of Day 1 of the VC, time will be dedicated to a technical session to refresh participants on the main features of the platform, and ensure connections are working properly.
