



ORGANISATION AND IMPLEMENTATION OF TRAINING ACTIVITIES ON

OFFICIAL CONTROL REGULATIONS 2020 96 06

UNDER THE "BETTER TRAINING FOR SAFER FOOD" INITIATIVE

1. Course objectives

General objective

The objective of this programme is to spread knowledge and best practices in relation to new role on the Official Control Regulation (OCR), to improve comprehension of this complex area of work and further harmonise the approaches and practices of the MS with a view to increasing the efficacy of the competent authorities/control bodies to verify compliance with the legal requirements in the field of statutory controls.

The "Official Control Regulation" (Regulation (EU) 2017/625) modernises EU control legislation by providing for more risk-based approach, by sharpening enforcement tools and by integrating more consistently the system of official controls in the animal health, plant health and plant reproductive material sectors. As to the financing of official controls, it aims to ensure the availability of stable and appropriate resources, ensure equity and fairness in the financing of official controls and improve transparency.

Specific objective

From a more specific point of view, the OCR programme aims to:

- Increase knowledge and provide for a common and unambiguous understanding of EU legislation and its' consistent and harmonised implementation across the EU and associated countries:
- Improve understanding and exchange the knowledge of the new, modern, risk-based approach in all areas covered by the scope of the Regulation (EU) 2017/625;
- Share the best practices and increase the general awareness of, and level of preparedness for, the EU regulatory framework for official controls along the agri-food chain;
- Disseminate the findings of the seminar as relevant and implement the possible solutions with respect to official controls and other official activities to be carried out in the Member States and associated countries as of 14 December 2019;
- Strengthen the Commission's priority's in the area of the European Green Deal and the Farm to Fork strategy for a fair, healthy and environmentally friendly food system.

Eligibility criteria for Course on Official Control Regulations

The training is addressed to both to officials from relevant competent authorities involved in policy making, planning and control activities (at central or regional level), and field inspectors involved in such control activities, including border control post staff, Plant Health Officers, Animal Health Officers, Food inspectors etc.

Participants must meet the minimum requirements below to ensure they can follow and fully participate in this course. Participants who do not meet the minimum requirements should not be proposed for the training.

ANNEX 1: BACKGROUND AND MAIN TOPICS COVERED IN TRAINING

Background

The objective of this project is to improve knowledge and to raise awareness of the new provisions, regime and approach which is adopted based on the "Smarter rules for safer food" principles.

On year 2013 The European Commission adopted a package of measures to strengthen the enforcement of health and safety standards for the whole agri-food chain.

The new package of provisions aimed to modernise, simplify, and strengthen the agri-food chain in Europe. The package responded to the call for the better simplification of legislation and smarter regulation thus reducing administrative burden for operators and simplifying the regulatory environment. The EU legislation covering the food chain consisted of almost 70 pieces of legislation. One of the goals of new package of reform was to reduce the number of legislation and to reduce the red tape on processes and procedures for farmers, breeders and food business operators (producers, processors and distributors) to make it easier for them to carry out their profession.

Europe had and still has the highest food safety standards in the world. However, the horsemeat scandal has shown that there is room for improvement, even if no health risk emerged. The new approach and the new reform had shown that the system can respond to challenges, and it also takes on board some of the lessons learned from the past providing the smarter rules for safer food.

The main elements of the package were official controls, animal health, plant health and plant reproductive material (including seeds).

The New Regulation (EU) 2017/625 (Official Controls Regulation) was published in March 2017 and the new provision applies from 14 December 2020. Regulation (EU) 2017/625 on Official Controls repeals the Regulation (EC) 845/2004 and Regulation (EC) 882/2004 Directives 89/608/EEC, 89/662/EEC, 90/425/EEC, 91/496/EEC, 96/23/EC, 96/93/EC and 97/78/EC and Decision 92/438/EEC. The Regulation (EU) 2017/625 also affects several other sectoral regulations in the areas covered by the Regulation.

Major changes and new elements that are being introduced with the new Regulation (EU) 2017/625 strengthen a high level of food and feed safety, public, animal, and plant health, and guarantee the functioning of the internal market.

The most significant changes that are introduced are the following:

- 1. Simplifies and reduces legal fragmentation;
- Strengthens the basic principles of previous laws;
- 3. Improves harmonization of procedures and standards;
- 4. Creates the legal basis for future and gives the Commission power to adopt delegated and implementing acts;
- 5. Establishes the rules for the performance of official controls and other related aspects such as
 - the financing of official controls;
 - the administrative assistance and cooperation between MS
 - the controls by the Commission in Member States and in non-EU countries:
 - the requirements for importing animals and goods into the Union;
 - the establishment of information management system IMSOC;
- 6. The scope of the regulation has been extended to cover the agri-food chain, including organic production and controls of marketing standards to identify fraudulent or deceptive practice;
- 7. Maintains the risk-based principle of official controls;
- **8.** Much attention is paid to detection of food fraud. Fraud is an essential element of risk and part of risk assessment;
- 9. Highlights the obligation of competent authorities to limit or minimise the burden on operators while performing official controls;
- 10. Ensure a high level of transparency of control activities performed by Member States in a harmonised and uniform manner. The scope of this obligation was clarified by identifying the minimum level of information that must be public;





- 11. Gives the possibilities to delegate official control tasks to delegated bodies or natural person. The conditions for delegation haven't changed;
- 12. Provide more flexibility for official laboratories;
- 13. More clarity on the methods for sampling, analysis, tests and diagnosis;
- 14. Implements the procedure of second expert opinion;
- 15. Provides a new structure for reference laboratories and centres;
- 16. Administrative assistance and cooperation plays important role in the new provisions. An important principle that was maintained is the requirement of Member States to facilitate transmission of information through liaison bodies between competent authorities. However, Regulation 2017/625 also requires Member States to facilitate transmission of information coming from law enforcement authorities, public prosecutors and judicial authorities, regarding cases of non-compliance which may pose a health risk or fraud.

Main Elements of Regulation (EU) 2017/625:

- 1. Extended scope covers:
 - Food and food safety;
 - Deliberate release into the environment of GMOs for the purpose of food and feed production;
 - Feed and feed safety:
 - Animal health requirements;
 - Prevention of risks to human and animal health arising from animal byproducts and derived products;
 - Animal welfare:
 - Protective measures against pests of plants;
 - Plant protection products;
 - Organic production and labelling of organic products;
 - Use and labelling of protected designations of origin (PGO), protected geographical indications (PGI) and traditional specialities guaranteed;
 - Official controls on animals and goods entering the Union or exported;
 - Official controls of marketing standards to identify possible fraudulent or deceptive practice.
- 2. Fully risk-based approach to official controls;
- 3. Tools to minimize the administrative burden on operators;
- 4. Designation of Competent authorities and provisions on cooperation between Member States:
- 5. Obligation of competent authorities and organic control authorities;
- 6. Operator rights of appeal;
- 7. Confidentiality obligations;
- 8. Methods and techniques of official controls;
- 9. Controls at any stages of production, processing, distribution and use;
- Increased transparency, possibility to publish results of controls and establish rating schemes;
- 11. Obligations of operators;
- 12. Additional specific rules for certain areas:
 - Food hygiene;
 - Residues;
 - Animal by-products and derived products;
 - Animal welfare;
 - GMOs in relation to food and feed production;
 - Plant protection products;
 - Organic production;
 - PGI and PGO;
 - Newly identified risks in food and feed.
- 13. Clarification about delegation of tasks of competent authorities;
- **14.** Provisions of sampling, analysis, tests and diagnosis in all areas the scope of official control regulation;





- Designation of laboratories. Permanent and temporary derogations from mandatory accreditation;
- 16. Clarification of cascade of methods to be used for sampling, analysis, test and diagnosis;
- 17. Second expert opinion as a tool to strengthen operators' rights;
- 18. Common framework for carrying official controls on animals and goods entering the EU;
- 19. The use of CHED by competent and custom authorities;
- 20. Designation and withdrawal of BCPs and minimum requirements:
- 21. Actions and measures that may be taken in cases of suspected non-compliance or non-compliances;
- 22. Approval of pre-export controls by the third countries:
- 23. Cooperation between competent authorities dealing with the animals and goods entering the Union:
- 24. Financing provisions regarding official controls and other official activities:
- 25. Uniform framework on official certification, issuance of official certificates and attestation;
- 26. Designation and responsibilities of reference laboratories and centres;
- 27. Strengthened mechanism for administrative assistance and cooperation;
- 28. Harmonised planning and reporting provision regarding MANCP and annual reports by the MS;
- 29. Commission power to perform controls in a MS and third countries, listing of third countries;
- 30. Conditions for the entry into Union of animals and goods and equivalence principle;
- 31. Rules on the training responsibilities of staff of the competent authorities;
- 32. Rules establishing a common information management system (IMSOC);
- 33. Broader scope reflected by modified non-exhaustive list of enforcement actions;
- 34. Reinforced rules on financial penalties for fraudulent or deceptive practices;
- 35. Repealed a number of sector specific official control provisions in different acts;
- 36. Empowerments to adapt official control requirements by delegated/implementing acts.

Bringing together participants from different EU MS should contribute to the dissemination of best practices for control procedures, increase the compatibility of these procedures and practices across the EU, ensure consistent and rigorous implementation of EU rules and allow exchange of experience among the MS.

The specific objective of this project is to improve knowledge of this complex area of work and further harmonise the approaches and practices of the MS with a view to increase the efficacy of the competent authorities/control bodies to verify compliance with the legal requirements in the field of protected designations.

Main topics covered in the training

This course is structured to raise awareness and improve knowledge of:

- Official Controls Regulation as a key element of the governance of the agri-food chain\ harmonised Union framework with the integrated approach;
- Overview of previous legislation highlighting the key changes that have been changed, scope, definition and terms used in the Official Controls Regulation;
- The link between OCR and other sectors, especially the veterinary and plant health. The role of official veterinarian and official plant health officer;
- Competent authorities' powers and responsibilities to carry out official controls;
- Collaboration between competent authorities and operators;
- Obligations resulting from the specific rules on transparency of official controls and the possibility for rating scheme systems for operators;
- Risk-based approach applied to the all planning of controls (e.g. use of past data and own-check results, adaptation of control frequencies);
- Specific conditions to be met for delegating certain control tasks from competent authorities to delegated bodies, practice of some member states;
- Official control and other official activities to verify compliance of products of animal origin intended for human consumption;





- Official controls on animals and goods entering the Union including rules on animals and goods
 other than those subject to official controls at border control posts and specific rules applicable
 to import controls on goods, animals and plants at border control posts, including practical
 aspects of implementation of procedures (best practices) for controls on imports/transits of
 products (documentary checks, re-entry of Union consignments, channelling, sampling of
 consignments, laboratory tests, re-enforced checks, non-conforming consignments, etc.) and
 cooperation with customs services;
- Actions taken in the cases of suspicion of Non compliance and of non-compliance of animals and goods entering the Union;
- Detection of fraud and regime for sanctions and penalties for fraudulent or deceptive practices\ focus on all sectors of the OCR, official control on e-commerce;
- Enforcement actions by the competent authorities and regime for sanctions and penalties for fraudulent or deceptive practices;

The information management systems (IMSOC) for official controls and mechanisms for administrative assistance and cooperation, official certification and attestation, the use of electronic certificates;

Specific rules on control laboratories, including reference laboratories, and on methods of sampling, analysis, tests and diagnosis used for official controls as well as to other official activities ('cascade of methods'), second expert opinion.


ANNEX 4: TECHNICAL REQUIREMENTS

The VC sessions will be organised with the use of the BigBlueButton web conferencing tool accessed via a secure Moodle LMS Platform. The participants will be invited to a brief introductory session on Moodle in the week preceding the training. At this introductory session, participants will be invited to log in and test connectivity, audio and video, with AETS staff available to troubleshoot any issues. It will allow participants to become familiar with the platform and the conferencing tool.

They will also receive some general information on the course and have the opportunity to ask questions and to begin to engage with the discussion forums.

The participants must have <u>a computer running the latest software and current browsers, with a working camera and audio system (speaker and microphone) as well as a good internet connection.</u>

Additionally, in the morning of Day 1 of the VC, time will be dedicated to a technical session to refresh participants on the main features of the platform, and ensure connections are working properly.

Participant will receive access to an off-line portal where they can find useful information, studies, activities to get familiar and integrate the knowledge shared during the event.

Dissemination questionnaire

Two to three months after the respective training session, participants will receive a standard questionnaire requesting information on the dissemination activities of the participant after the training, and details on differences in the approach adopted in day-to-day work following the training.

Self-assessment test

Furthermore, the programme will include an anonymous knowledge test to be carried out at the beginning and at the end of each training session in order to measure the impact of the training on the understanding of the participants of the subjects taught.

Participants are expected to agree to carry out the above tests and to reply to the surveys and questionnaires. Participants agree to be registered in the BTSF Academy and agree to be recorded during Virtual Classroom Training sessions and to take a group photo of the participants and tutors at the end of the training. Videos and photo will be published in the BTSF Academy in the corresponding Training course section and will be visible only to the registered participants in that Training course.
