The below list of Joint Actions corresponds the Work Programme for 2021¹ arranged in two waves.

Overview of the first wave:

EU4H-2021-JA-01: *Direct grants to Member States' authorities: support to coordinated and expedited assessment of clinical trials for COVID-19 therapeutics (AWP Ref: CP-g-01.1.2)* – Budget: 2 000 000 EUR.

EU4H-2021-JA-02: *Direct grant to Member States' authorities: support to assist Member States to roll out large-scale human papillomavirus vaccination campaigns (AWP Ref: DP/C-g-08.1.2)* – Budget: 3 800 000 EUR.

EU4H-2021-JA-03: *Direct grants to Member States' authorities: network of Comprehensive Cancer Centres: Preparatory activities on creation of National Comprehensive Cancer Centres and EU Networking (AWP Ref.: DP/C-g-10.1.2)* – Budget: 3 000 000 EUR.

EU4H-2021-JA-04: *Direct grants to Member States' authorities: network of Comprehensive Cancer Centres: Establishment of new EU Network of Expertise on Cancers and Cancer Conditions (AWP Ref.: DP/C-g-10.1.3)* – Budget: 4 000 000 EUR.

EU4H-2021-JA-05: *Direct grants to Member States' authorities: strengthening eHealth, integrating telemedicine and remote monitoring in health and care systems for cancer prevention and care (AWP Ref.: DP/C-g-11.3.1)* – Budget: 4 000 000 EUR.

Overview of the second wave:

EU4H-2021-JA-06: *Direct grants to Member States' authorities: **availability of medicines, shortages and security of supply*** (AWP Ref.: CP-g-01.1.1) – Budget: 10 000 000 EUR.

EU4H-2021-JA-07: *Direct grants to Member States' authorities: **Union and national surveillance systems*** (AWP Ref.: CP-g-02.1.1) – Budget: 7 000 000 EUR.

EU4H-2021-JA-08: *Direct grants to Member States' authorities: **implementation of best practices and research results on prevention of non-communicable diseases and risk factors*** (AWP Ref.: DP-g-07.1.1) – Budget: 7 000 000 EUR - one or two thematic joint actions: decision will be taken prior to the opening of submission of the nomination for the second wave.

EU4H-2021-JA-09: *Direct grants to Member States' authorities: **transfer of best practices in primary care*** (AWP Ref.: HS-g-14.3.1) – Budget: 10 000 000 EUR - one or two thematic joint actions: decision will be taken prior to the opening of submission of the nomination for the second wave.

EU4H-2021-JA-10: *Direct grants to Member States' authorities: **health workforce to meet health challenges – forecasting and planning for workforce in the healthcare sector*** (AWP Ref.: HS-g-15.1.1) – Budget: 7 000 000 EUR.

EU4H-2021-JA-11: *Direct grants to Member States' authorities: **to promote quality of medicines and to increase cooperation between the Member States and between the Union and third countries through trainings, joint audits, reassessments and inspections on good manufacturing and good distribution practices (GDP). Implementation of international mutual recognition agreements on pharmaceutical good manufacturing practices (GMP) with the United States, Switzerland, Australia, Japan, New Zealand, Canada, Israel, the UK, and cooperation with third countries such as China and India*** (AWP Ref.: HS-g-18.2.1) – Budget: 2 150 000 EUR.

EU4H-2021-JA-12: *Direct grants to Member States' authorities: **safety assessment cooperation and facilitated conduct of clinical trials*** (AWP Ref.: HS-g-18.3.1) – Budget: 4 500 000 EUR.
